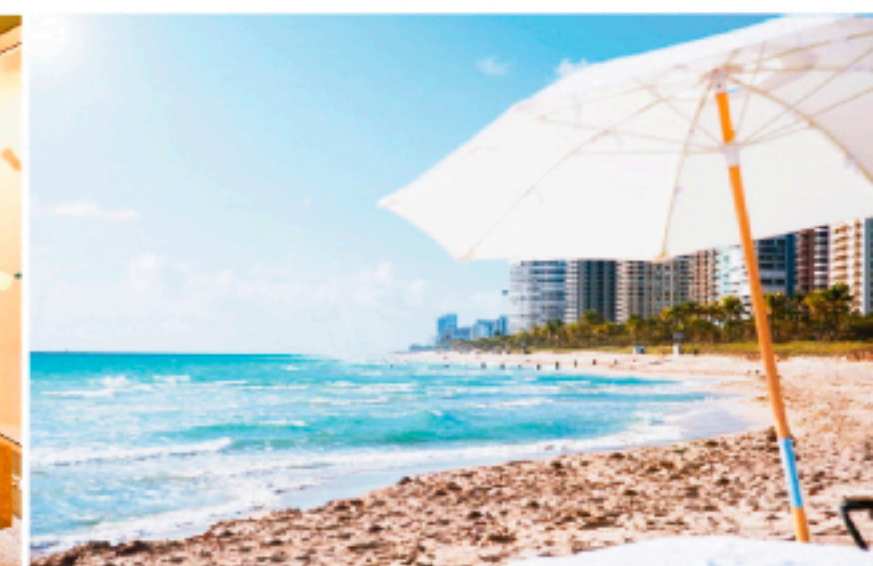



Location
